Registration Fee: \$65

- There is a 5% discount, if tuition is paid in full by September 1, 2025
- All dancers must be enrolled in autopay. Tuition payments for children's classes must be made by credit
 card directly on MSDC's dance studio software (Dance Studio Pro) or via ACH payment. If you elect to
 pay by credit card, a valid credit card must be on file at all times and there will be a convenience fee of
 3.5% per transaction. If a credit card charge fails because the card is invalid or an ACH payment is
 declined, the dancer's account will be suspended and the dancer will be ineligible to take class.
- A late fee in the amount of \$40 will also be applied to the account five days after the due date, if the
 account is not paid on time or if a credit card payment is rejected and the account is removed from
 autopay. The late fee will need to be reconciled before the account can be re-activated and the student
 allowed to resume classes. There are no make ups for classes missed.
- Payments for the dance school year may be made in 8-installments (September through April) for the September 2025 to May 2026 season, unless a 9-installment plan is selected and begins in August 2025.
- In the event, that the student is in the Junior/Senior Division and takes 5+ classes which included multiday classes, there is an option to pay tuition in 9- installments beginning on August 1, 2025 only (and concluding on April 1st, 2026).
- Each of the eight payments is due on or before the 1st of the month from September 1, 2025 through April 1, 2026. Costumes will not be distributed to any student with an outstanding balance.
- Again, after 5 days, a delinquent account will be assessed a late fee of \$40 and the dancer will not be allowed to take class. Unfortunately, there are NO exceptions. In the case of an outstanding balance after April 1st, 2026, a \$50 late fee will be assessed each month. Delinquent accounts are subject to collections.
